


Strengthened Aged Care Quality Standards

- The strengthened Aged Care Quality Standards come into effect on 1 July 2025
- Palliative care and end-of-life care have been recognised as core business for aged care.
- Standard 5: Clinical Care, including Outcome 5.7 which relates to palliative care and end-of-life care



Standard 5 – Outcome 5.7

- The provider must recognise and address the needs, goals and preferences of individuals for palliative care and end-of-life care, and must preserve the dignity of individuals in those circumstances.
- The provider ensures that the pain and symptoms of individuals are actively managed, with access to specialist palliative and end-of-life care when required.
- The provider must ensure that supporters of individuals and other persons supporting individuals are informed and supported, including during the last days of life.

What is ELDAC?

Funded by the Australian Government Department of Health, Disability and Ageing, [ELDAC](http://www.eldac.com.au) (End of Life Directions for Aged Care) is a free online resource for aged care workers and health professionals caring for older people at the end of life.

ELDAC aims to:

- Build palliative care and advance care planning knowledge, skills and linkages in aged care and primary care.
- Promote lasting change at the individual, service and system levels of aged care and primary care.
- Make lasting change that enables a reduction of avoidable hospital admissions, with shortened stays, and improved quality of care for people supported in residential and community aged care programs.



Linkages Program – Objectives



Provide specialist palliative care and ACP **guidance** to aged care providers and GPs



Improve linkages between aged care services and palliative care services



Improve the palliative care **skills** and advance care planning **expertise** of aged care service staff and GPs



Improve the quality of care for aged care recipients, **prevent unnecessary hospital admissions**, and **shorten hospital stays**

Linkages Program – Key Milestones



Complete pre-implementation audits (T1, baseline)



Review results and needs analysis report / feedback



Complete mapping of local/regional service providers



Connect and set up partnerships



Develop and implement an action plan



Complete post-implementation audits (T2, 6-9 months after T1)



Participate in activities to promote sustainable change

Linkages Program – Service Data

- The ELDAC Linkages Program has been implemented in over 300 Aged Care services in Australia
- Previous data demonstrates improvement in advance care planning and palliative care processes within aged care services after participation in the program
- A number of these improvements relate to Outcome 5.7

The provider must **recognise and address the needs, goals and preferences** of individuals for palliative care and end-of-life care, and must preserve the dignity of individuals in those circumstances.



Percentage of services which mostly or completely met this item before and after the program (n=86)





Percentage of residents/clients who had a documented ACP/ACP before and after the program





The provider ensures that the **pain and symptoms of individuals are actively managed**, with access to specialist palliative and end-of-life care when required.



Percentage of services which mostly or completely met this item before and after the program (n=86)





T1 (n=2000)




T2 (n=1799)

The provider must ensure that supporters of individuals and other persons supporting individuals are **informed and supported**, including **during the last days of life**.



Percentage of services which mostly or completely met this item before and after the program (n=86)





Question 26: Were the palliative care needs of the family met in the last week of life?





Clinical staff skills and confidence in assessing family bereavement needs and referring if necessary




Feedback from previous participants

- *We have increased resident awareness in Advance Care Planning and Palliative Care, and family involvement in Palliative and End stage care when needed. We have experienced an increase in positive feedback from families. We are seeing better outcomes from family conferences and staff feel more comfortable discussing end of life wishes with residents and families*
- *Staff who were previously unable to entertain conversations about end-of-life care with clients due to overwhelming sadness, fear etc are now feel comfortable and confident to do so*
- *The impact of this program extends beyond the short term, creating a lasting effect*
- *Palliative and End of Life care is a Continuous improvement project and will continue to take traction to build upon what we are doing as a provider, and how we can develop and improve upon what we are doing*
